WHEREAS, Ms. Gloria Ann Beltran is being honored for her exceptional work and dedication to the County of Hidalgo after serving with distinction and integrity for the past 38 years; and

WHEREAS, in 1988 she was hand-picked to work with Commissioner Norberto Salinas in Precinct 3. By 1997 she was a personnel manager for Commissioner Juan Rosel in Precinct 3 and later went on to work as an administrative assistant for Commissioner Oscar Garza in Precinct 4. Ms. Beltran served as Executive Assistant IV for Precinct 4 Commissioner Joseph Palacios from 2011 until her retirement in February 2015; and

WHEREAS, after serving for 38 years, Ms. Beltran looks forward to spending more time with her family, including her parents, five children and three grandchildren. As an active member of Sacred Heart Catholic Church, Ms. Beltran will be volunteering her time to the Church's administrative department. She also looks forward to traveling; Ms. Beltran will make a pilgrimage to Rome for 13 days as a member of the Sacred Heart Guadalupana Society.
