As stated in the plat for Angela Subdivision, the names 28th Street and 29th Street are identified but are not in numerical sequence to the street names that follow. In fact, both are represented again proceeding south on Bridge Ave.

The LRGVDC 9-1-1 Department proposes that 28th and 29th Street be renamed to 22nd and 23rd Street respectively to correct the street names in this area numerically from 22nd thru 29th Street.

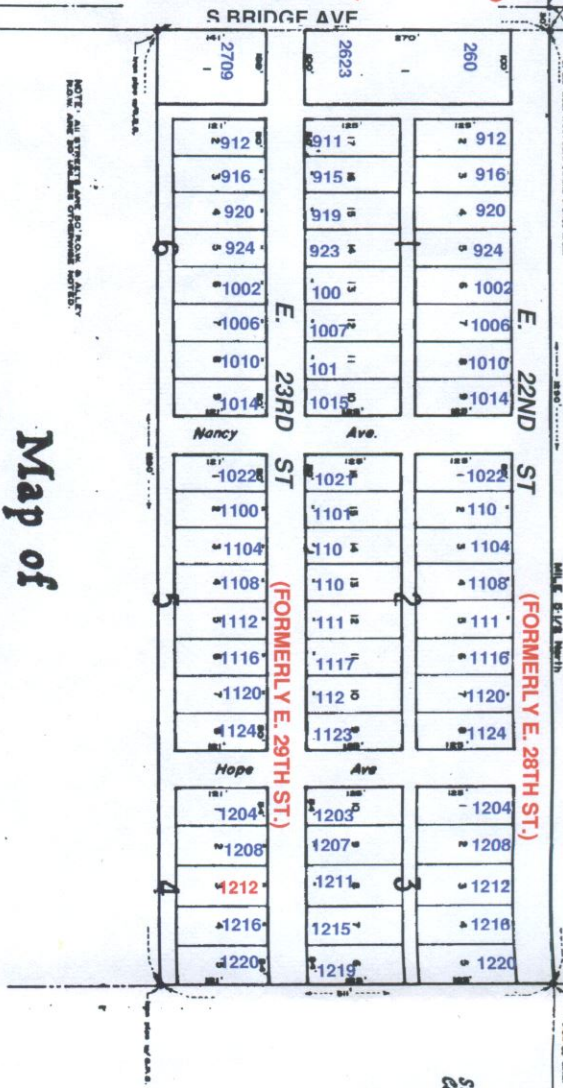

Thence: east for a distance of 30' (30m) to a point, said point being in the east R.O.W. line of a dedicated 80' road;

Thence: east for a distance of 180' (180m) to a point, said point being the northeast corner of lot 10 block 140 of said ft. 788 and of this survey;

Thence: south for a distance of 81' (81m) to a point, said point being the southeast corner of this survey;

Thence: west for a distance of 80' (80m) to a point, said point being in said R.O.W. line of a dedicated 80' road;

Thence: west for a distance of 30' (30m) to a point, said point being in the west line of said lot 10 and the southwest corner of this survey;

Thence: north for a distance of 81' (81m) to the point of beginning and containing 1/2 S. Acres, more or less.

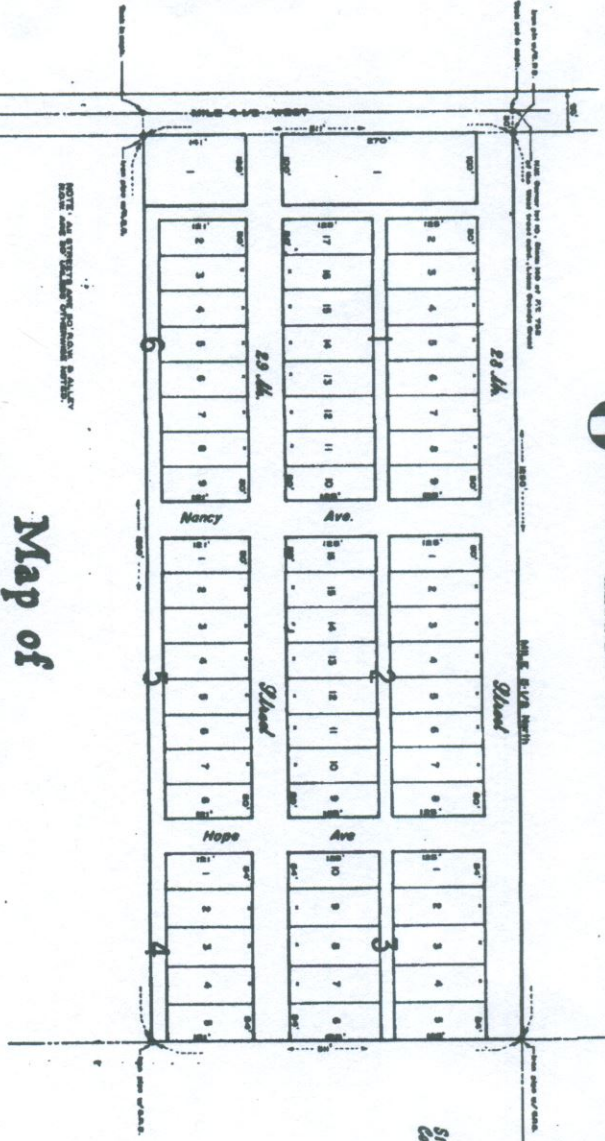
