There were several clauses that caused us some concern but after reviewing them as a team we concluded that requesting an accommodation from TWC would be futile. Usually, we would request a modification of jurisdictional clauses, however given the overall enforceability of such a clause against the county, the likelihood of accommodation by a corporation of this size and the delay that such a course of action would cause we have decided not to pursue such demands. Please do not interpret this as a waiver of future objections to jurisdictional language.
