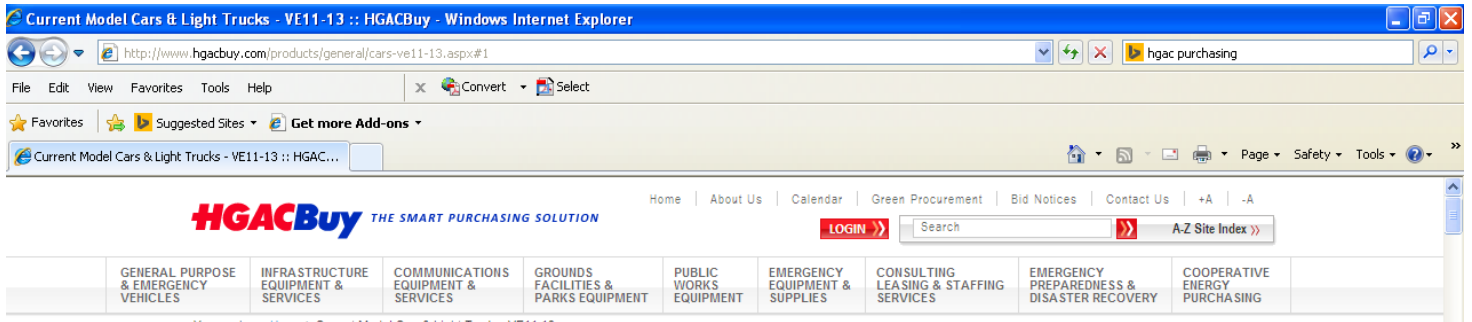

- 4) Show cost per mile for delivery of vehicles to our members (see Question #5). If your company uses a sliding mileage scale or uses a different method for arriving at this cost, explain in detail below.

Question No. 1.

What is the complete name of the OEM catalog you are submitting with your bid?

Answer: 2014 Ford Motor Company Price list, price levels 415-420 as applicable by model code

Question No. 2.

What are the effective dates of this OEM catalog?

Answer: Effective for the 2014 model year. Final balance out dates per model TBD Ford Motor Co.

Question No. 3.

Does the OEM catalog show MSRP pricing?

Answer: Yes

Question No. 4.

What is the percentage of discount off the MSRP for the entire catalog?

Answer: Discount Percentage: 6 %

Question No. 5.

Cost per mile for delivery or explain how your company arrives at a delivery cost for delivering vehicles.

Answer: Cost Per Mile \$ 1.75 to deliver vehicles. (This is the maximum cost. Often, substantial discounts are available depending on volume. Delivery discounts will be passed on to H-GAC end users.)
