The HEPRS Program has approved \$70,000 in additional funding to Hidalgo's one-time funding contract in support of their 2016 Hurricane conference. To consolidate efforts and to streamline the contractual process, please add this finding to the One – Time Unique Budget that is due on Friday, 07/10/2015. The total contract amount or (DSHS Funds Requested) should reflect a total of \$147,344 which is \$77,344 (FY16 BP4 PHEP Flat Rate Award) and the additional \$70,000 (2016 Hurricane Conference). The budget should also reflect a 10% Match Requirement or \$14,734.00.

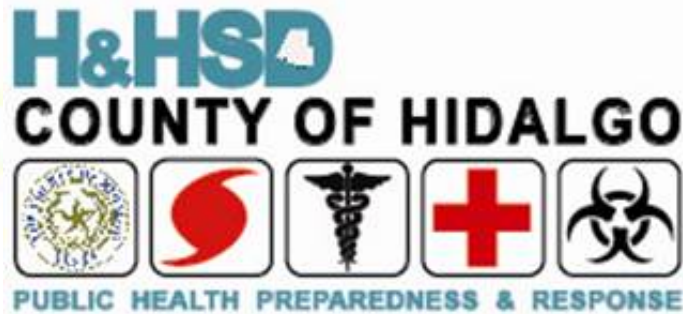
