I have a concern with paragraph 10, as worded (highlighted in the attached document). Here is some recommended language you can replace it with.

This Agreement contains the entire contract between the parties hereto, and each party acknowledges that neither has made (either directly or through any agent or representative) any representations or agreements in connection with this Agreement not specifically set forth herein. This Agreement may be modified or amended only by agreement in writing executed by each party, and not otherwise. This Agreement shall be construed under and in accordance with the laws of the State of Texas.

This is the language we use in other interlocal agreements.
