The Texas Department of State Health Services, Tuberculosis (TB) Services Branch, is initiating the contract application process for fiscal year (FY) 2016 for TB. The award is for the period January 1, 2016 through December 31, 2016. At this time we are requesting a one year detailed budget. At a later date DSHS will send a request for the full Inter-local Application for TB. The deadline for the budget submission is Tuesday, July 28, 2015. We apologize for the short turn around but this is due to the deadline imposed by CDC to DSHS.

The FY2016 budget allocation is 437,771. Contractor shall provide a match of no less than 20% of the DSHS share of the total budget which is \$87,554.
