Pursuant to Local Government Code § 111.0706 SPECIAL BUDGET FOR GRANT OR AID MONEY:

The county auditor shall certify to the commissioners court the receipt of all public or private grant or aid money that is available for disbursement in a fiscal year but not included in the budget for that fiscal year. On certification, the court shall adopt a special budget for the limited purpose of spending the grant or aid money for its intended purpose.

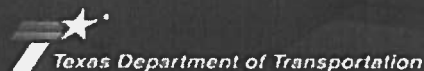

The Memorial Day Click It or Ticket campaign was conducted May 18-31, 2015.

TxDOT conducted an Incentive Award program to engage non-funded law enforcement agencies statewide. The goal of the program was to increase the number of law enforcement agencies participating in the Memorial Day Click It or Ticket campaign. The Incentive Awards program offered all non-funded Texas law enforcement agencies statewide the chance at being selected to receive a \$3,000 award that could be used for the purchase of traffic safety equipment and/or training.

A total of 133 law enforcement agencies registered and reported this year. To be eligible for the random drawing, law enforcement agencies were required to increase Seat Belt and Child Safety Seat enforcement as well as conduct earned media efforts and report the results at the campaign's conclusion.

Congratulations to Hidalgo County Sheriff's Office, the agency has been selected to receive an incentive award for its participation in the FY 2015 Memorial Day Click It or Ticket Summer Incentive.

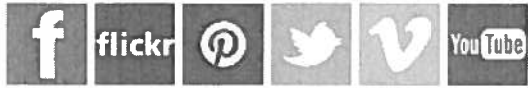
