Steve: In our ongoing effort to maintain good relations(!) (and, btw taxpayer efficiency), may we again tackle the topic of items being presented to my Commission as "approved by the County" and then being changed afterwards?

Your PCT #4 person called us and then sent these over. Just so you will be aware, these are the documents (before your mark-ups) that we were told were "County documents" and ready for approval. Now we are being told (after my Commission has approved them 'as is') that they are going to Commissioners' Court with changes recommended. (Perhaps your office was not aware that the City had already approved them?)

FWIW, we don't see any major problems with the mark-ups, but you should know getting the Mayor to sign something after its been approved (and then changed) is sometimes a coin toss. Given the Holiday schedule, this could mean that they don't get final approval ('final final approval?') over here until January 11, 2016.

(Again, I don't see anything particularly wrong with the changes—just the 'order' of things.)
