**AMENDMENT NO. 3 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN  
HIDALGO COUNTY ACTING BY AND THROUGH THE HIDALGO COUNTY URBAN  
COUNTY PROGRAM AND DOS LOGISTICS, INC.**

This Amendment No. 3 to the Agreement is made this \_\_\_\_ day of \_\_\_\_\_, 2015 by and between Hidalgo County, Texas (the "County") and DOS Logistics, Inc., (the "Engineer").

WHEREAS, Hidalgo County received funds from the Texas General Land Office (GLO) to be used for the completion of the Precinct No. 1 – Delta Area Connector /East Lateral project;

WHEREAS, Engineer and County entered into a Professional Services Agreement (the "Agreement") dated May 22, 2012 for engineering services for the Delta Area Connector;

WHEREAS, Amendment No. 1 added additional services for Engineer and increased the fee to the Engineer under the Agreement to \$992,411.00;

WHEREAS, Amendment No. 2 added additional services and increased fee to Engineer by Sixteen Thousand Four Hundred Fifty and no/100ths Dollars (\$16,450.00);

WHEREAS, the Agreement now requires an amendment in order to add additional services as required for parcels associated with the project; and

WHEREAS, the parties desire to amend the Agreement as herein after provided.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Engineer hereby agree to the following amendment to the Agreement:

1. Exhibit A of the Agreement is amended by the addition of Exhibit A-3, a copy of which is attached hereto.

2. The first sentence of Section 6.1 of the Agreement is deleted in its entirety and the following is substituted in lieu thereof:

The Engineer shall be paid a total fixed amount of \$1,045,497.60 for services rendered under this contract.

3. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and Engineer and County ratify and confirm the terms and provisions of the Agreement as amended.
