In response to your request to initiate a data sharing contract, I have attached an explanation of online and offline access, along with a Contract Request Form to be completed by you (or the appropriate person in your organization) and signed by the person who will sign the actual contract. Please be sure to respond to each item.

**NOTE: This document is NOT a contract.**

The use of our data is limited to what is spelled out in the purpose, so please include all that apply. To use the data for a purpose other than what is stated in the contract is a violation!

- 1) To access TWC information on an ongoing contract between TWC and Texas State University must be executed
- 2) Contracts are only for Governmental Entities
- 3) Contracts are only provided if the purpose is for administrated enforcement of a law
- 4) The government entity must agree and retain confidentiality with safeguards

Release is only permitted in very limited circumstances
