Attached for your review and comment as to form is a modified awarded consulting services contract with Alamo Insurance for our Self Funded Group Health Plan. The vendor submitted the final form of agreement. It was sent to you for review and approval as to form [which you did approve]. When the contract went to County Judge for execution, it was observed by Judge's staff that the scope of services on the vendor's contract document were not inclusive of the list on the original RFP. Judge did not want to execute as he felt [and we agree], the full list of services needed to be incorporated into the document. Thus, we are providing you a modified [vendor generated document] incorporating language that will reference the scope of services in RFP-Exhibit A and made part of the agreement. Alamo is in full concurrence and informs us that it was always their intent to provide all the services listed on the original RFP document but failed to list them on their proposed contract. Ms. Yvette Salinas, Buyer also failed to notice that 2 of the listed services were missing. Please let us know of your review so as to place on the next HCCC agenda for approval of the modified document.
