Hon. Members of HCCC and Mr. V. Guerra:

In reviewing the action taken by CC in connection with the joint nomination of seven firms from both Surveyor and Engineer [with Civil noted as a Discipline by the firm] Pools, we find that 3 nominees are not on the approved "pool" of Surveyors. If memory serves me well, the action taken by CC was to engage both services using/combining both "pools". Thus, I believe the Item needs to be placed on the next HCCC meeting [03-22-16] for reconsideration and applicable action to correct the issue. If you can recommend any other remedy, please advise so I can consult with legal counsel on the matter. This is the only item that appears to have a problem. We will be distributing all other items [i.e. Materials Testing/Geo-technical Services and Architect Services] for the purpose of grading/scoring with dates for return of the sheets so as to place on the next CC for ranking and continuing the next phase of the process.
