Ms. Yvette,

Victor and I took a look at the agreement and had a couple of concerns:

1. On page 2 at paragraph 6 - this language about the possibility of a student being an employee is inconsistent with further language in the agreement (I can not see any reason why a student would be a County employee but I would suggest confirming this with WIC); otherwise, it should be removed;
2. Paragraph VII. is an indemnity provision; we recommend including the

following language "to the extent permitted under the Constitution and Laws of the State of Texas.";

3. Paragraph XII, is an agreement to pay attorneys fees and costs; we recommend removing it.
