Dear Chief Padilla,

The 2014 Operation Stonegarden performance grant period will end June 30, 2016. Total funding awarded to Hidalgo County under Operation Stonegarden 2014 was \$4,674,438.00. These funds were shared with seventeen (17) local law enforcement agencies which were invited to participate in 2014 Operation Stonegarden.

The Hidalgo County Sheriff's did request and receive a supplemental amount of \$400,000.00 in Operation Stonegarden 2014 funds. We did reach out to our participating agencies which had expended their funds and offered them additional funds.

The Mission Police Department was awarded \$300,000.00; however, they have already exhausted all of their funds. The Hidalgo County Sheriff's Office is respectfully requesting authorization to make the following changes in funding in order to assist Mission Police Department to continue with the operation.

Pharr Police Department:

The Pharr Police Department was awarded \$300,000.00; however, they have already expended all of their funds. The Hidalgo County Sheriff's Office is respectfully requesting authorization to make the following changes in funding in order to assist the Pharr Police Department to continue with the operation.


