This **SECOND AMENDMENT** to Contract is made this ___ day of _____, 2016 by and between **HIDALGO COUNTY, TEXAS** (the "COUNTY") and **BRIDGEPOINT INSURANCE AGENCY & PERMIT CENTER LLC** (the "Full Service Deputy").
