**SECOND AMENDMENT TO PROFESSIONAL ENGINEERING SERVICES AGREEMENT
(C-11-099-05-24)**

This **SECOND AMENDMENT** to the professional engineering services agreement for: **“Ground Water, Gas Monitoring and Groundwater Data Evaluation at Closed Landfill Site”** located within **Hidalgo County Precinct No. 4** in connection to contract# **E-15-185-04-28 (C-11-099-05-24)**, dated May 24, 2011, by and between **Hidalgo County, Texas** (“County”) and **George M. “Mitch” Hudgins d/b/a Modern Technology-Modern Environment** (“Engineer”) is entered into between the parties effective this **10TH** day of **May, 2016**.

WHEREAS, Engineer and County entered into an Agreement dated May 24, 2011, in which Engineer agreed to provide professional engineering services for the purpose of **“Ground Water, Gas Monitoring and Groundwater Data Evaluation at Closed Landfill Site”** located within **Hidalgo County Precinct No. 4** (the “Contract”);

WHEREAS, TCEQ has advised the Engineer that the “Groundwater Sampling and Analysis Plan” (GWSAP) needs to be extended through amendment in accordance to article 7-amendments for the period of services in order to comply with TCEQ;

WHEREAS, the County desires to extend the term of the Agreement due to Engineer’s experience with the closing of the landfill and TCEQ compliance issues;

WHEREAS, the Engineer, and County now desire to amend the Professional Services Agreement to amend the term of the agreement to extend for an additional (1) year period in order to remain in compliance with TCEQ; and

WHEREAS, the parties desire to amend the Agreement as hereinafter provided.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. The first sentence of numbered paragraph 2 of the Agreement is deleted in its entirety and the following is substituted in lieu thereof:
 2. Term. This Agreement shall commence upon approval of this Agreement and shall terminate on May 23, 2017 unless earlier terminated as provided herein.

2. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and Company and County ratify and confirm the terms and provisions of the Contract as amended.
