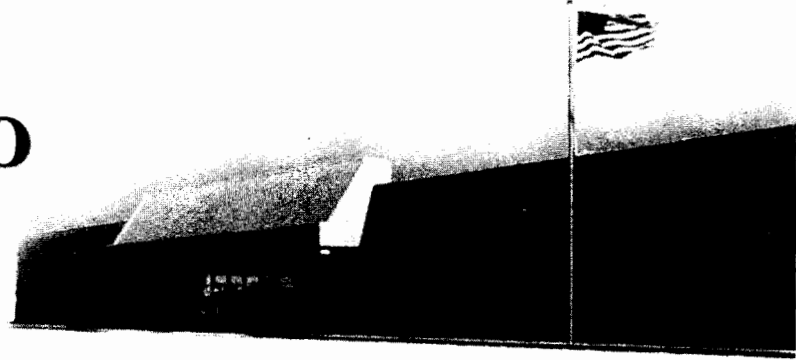



Gentlemen:

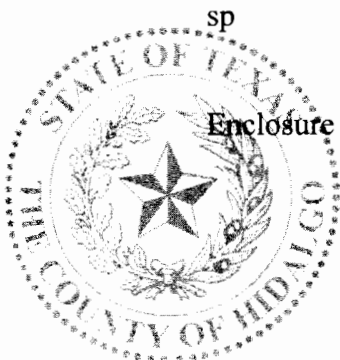
