FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

This First Amendment to Professional Services Agreement is made this ____ day of July, 2016 by and between Urban County Program (the "Party") and South Texas Infrastructure Group, LLC acting by Julio Cerda, proposed engineer (the "Engineer").

WHEREAS, Party and Engineer entered into a that certain Professional Services Agreement dated February 16, 2016, in which Engineer agreed to provide certain services for the purpose of street improvements for La Joya Avenue and Pike Avenue in the City of Penitas, Texas;

WHEREAS, by error a third street was identified in Exhibit A to the Professional Services Agreement as requiring engineering services;

WHEREAS, the parties desires to amend the Professional Services Agreement to delete such third street from the Professional Services Agreement.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Party and Engineer hereby agree to the following amendment to the Agreement:

1. Exhibit A is deleted in its entirety and Exhibit A attached hereto is substituted in lieu thereof;
2. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect. County and Contractor ratify and confirm the terms and provisions of the Contract as amended.
