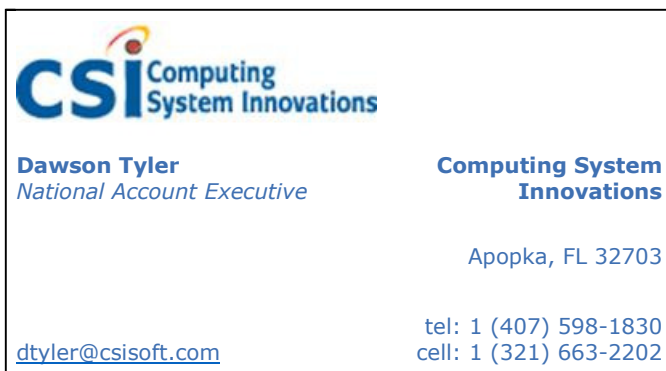

Dawson:**The following modification are being requested by our legal counsel:****Master Service Agreement**

Section 16.1 Requires the County to indemnify CSI

Section 16.2 Requires the County to provide a defense and hold CSI harmless.

****Recommend including the following language for these two provisions: "to the extent permitted under the Constitution and laws of the State of Texas."**

Section 19 - Term - is indefinite; the County cannot be obligated indefinitely.

Further, only allows for termination by cause and/or by agreement.

Section 21.1 - Governing law - Florida; the County cannot agree to jurisdiction outside of the state of Texas.

Maintenance Agreement

Section 3 - Initial Maintenance Term is unclear

Section 15 - Termination; only allows for termination for cause or 90 days prior to the end of the term

Confidentiality Agreement

Section 3.0 - Governing law is Florida; see note above.

Please provide agreements with the requested modification so we may proceed with approval to execute agreement.

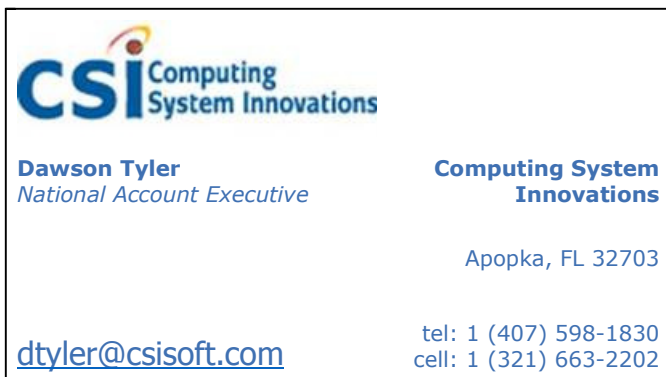
