HHSC has been made aware of an issue with respect to the IGT settlement date for the upcoming DY5 UC Payment. Many government entities are beginning a new Fiscal Year and will not have access to their funding until after September 1st. As a result, they have asked HHSC to revise our timelines to accommodate a later settlement date. The revised timeline for the upcoming DY5 UC Payment is below.

August 25th UC IGT Notification
September 8th Last day to enter TexNet
September 9th IGT Settlement Date
September 30th Latest date DY5 UC Payments will be made

The IGT Commitments are still due by COB August 19th.

Texas Medicaid must comply with federal regulations, which now requires all providers to revalidate their enrollment information every three to five years. In accordance with this federal mandate, **Texas Medicaid requires all providers that enrolled before January 1, 2013 to re-enroll by September 25, 2016.** Providers can begin this process immediately. Providers can find more information about the federal mandate [here](#). TMHP will hold workshops in various locations around the state, so that providers will have the opportunity to receive personalized help with the re-enrollment process. Providers will be informed of the locations of the workshops, along with specific dates and times, in upcoming articles at TMHP.com.
