The only concern I see is at Paragraph 16 which requires HIDTA (as the customer) to indemnify them. Legally, there is a constitutional prohibition limiting HIDTA's ability to perform such indemnification. For that reason, I would recommend adding the following language to this provision.... "to the extent permitted under the laws and constitution of the state of Texas."

This same indemnification provision appears in the addendum. We would again request that this additional language be included there as well.
