1. SCHEDULE A TERM

The term of this Schedule A will be 12 months beginning September 1, 2016 (the "Initial Term"), and shall automatically renew for additional periods of twelve (12) months (each one, a "Renewal Term"), unless a party provides written notice of termination to the other at least ~~thirty (30)~~ days prior to the expiration of the Initial Term or any Renewal Term. If an account is activated after the first day of a calendar month, charges will not be prorated.

At the end of each twelve-month period User Fees will be increased 5%

2.3 Payment Amount: Customer shall pay to LN each month the greater of (i) total User Fees or (ii) the total monthly minimum amount(s) as specified in the Price Table.
