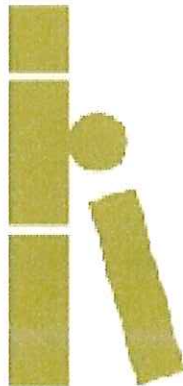



For Fiscal Year 29(2016) the Dr. Hector P. Garcia Memorial Library will be purchasing a table and four corresponding chairs. Also being purchased are 26 chairs on casters for the computer carrels. The total cost for all the furniture comes to \$13,306.54. We have been allocated \$13,000 in Urban County funds. I propose paying the remaining \$306.54 out of the library budget. Currently, we have \$1,007.72 remaining in the account number 01-536-3055 (Other). This would be more than sufficient to cover the remaining balance and still leave adequate funds in the account.



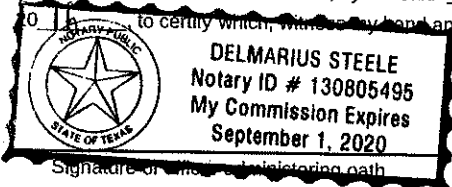
