**On 10/4/16 at 0927 hours, I Officer Christopher Welch #70 was dispatched to the Juvenile Detention Center located at 1001 North Doolittle Road in reference to a theft.**

**I arrived at the location and made contact with the reporting party, facility administrator, Eduardo Martinez.**

**He stated that on 9/26/16, he was reviewing an inventory of their portable radios and noticed that two of them were missing.**

**He stated that they searched the facility for them but they could not be located.**

**He stated that he believed that they had been stolen, but did not know exactly who was responsible for the theft.**

**He stated that one of the radios was a Harris brand XG 75 700/800 MHZ radio valued at \$2100 (Serial# A4020400393F).**

**He stated that the other radio was a Harris brand MAEV P7350 radio valued at \$2750 (Serial# A401210055B0).**

**He stated that he would like to file charges against those responsible on behalf of the detention center.**

**He also provided a photo copy of a typed affidavit (see attached).**

**I provided him with a case number and he was informed that a report would be filed.**

**Both radios were entered into the NCIC/TCIC system as stolen (see attached).**
