This amount includes **\$2,932,858.00** for non-housing and **\$1,380,169.00** for housing assistance. UCP will hold a public hearing on the MOD process to receive public comments on the use and distribution of these funds. Additionally, public meetings will be scheduled to receive input on the needs assessment and application to be submitted to the General Land Office (GLO). 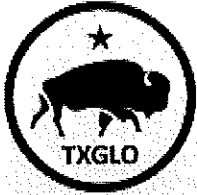

2015 Texas Floods and Storms CDBG-DR Allocation

The GLO's Community Development and Revitalization (GLO-CDR) program will oversee administration of \$50,696,000 in Community Development Block Grant Disaster Recovery (CDBG-DR) funds provided by the U.S. Department of Housing and Urban Development (HUD) for recovery from the storms and flooding events in 2015. There are 116 Texas counties eligible for recovery funding as a result of receiving a Presidential Disaster Declarations in 2015. Cities, counties, and housing authorities in the declared areas are eligible to apply.



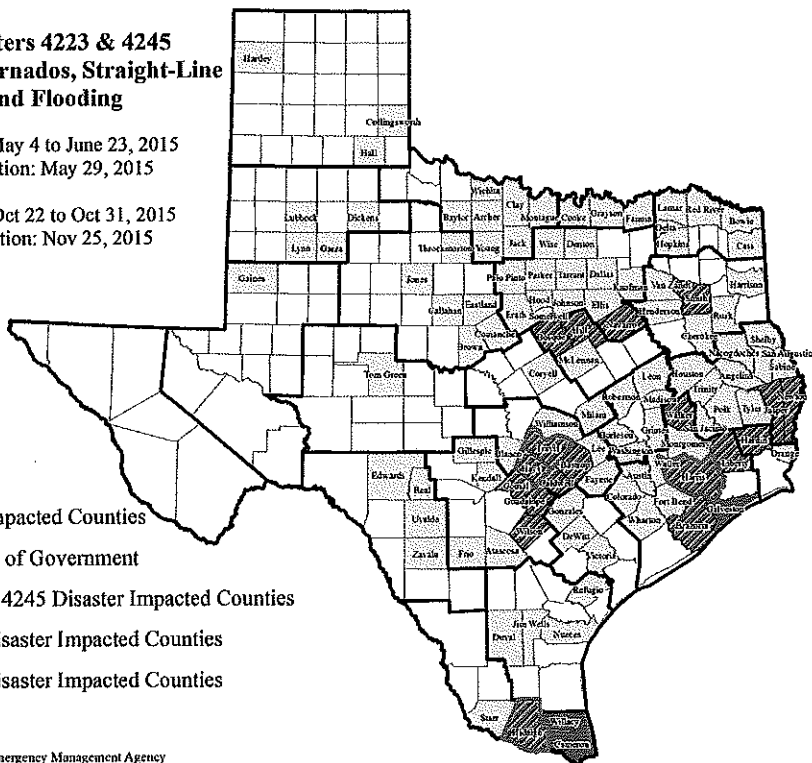
