Can you please research and provide guidance on this service road for 911 purposes. Please feel free to call me with any questions or concerns. Attached are some documents of the area in questions. Thanks.

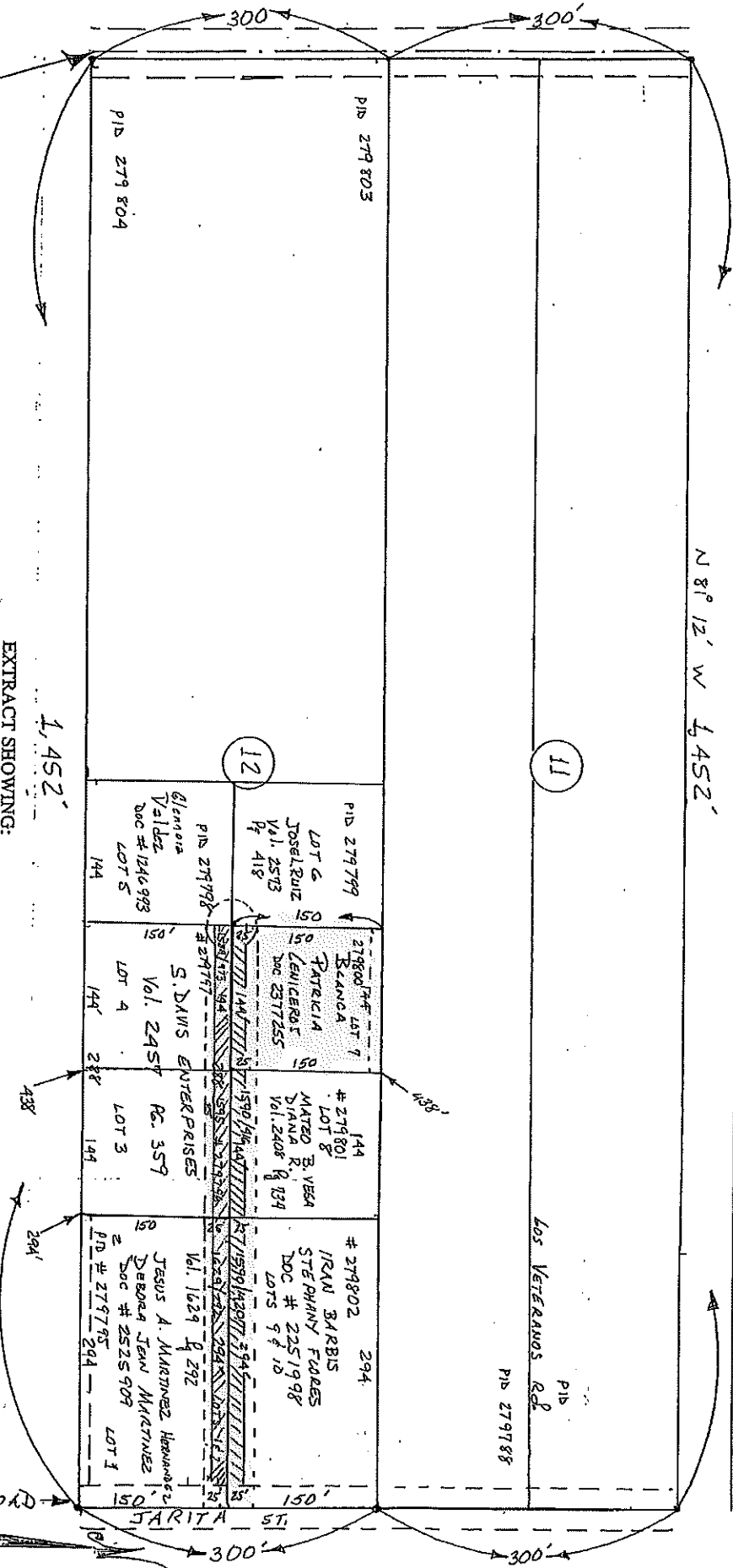
