**AMENDMENT TO
CONTRACT #C-14-351-11-18**

This **AMENDMENT** to the **CONTRACT** is made this 24TH day of **JANUARY of 2017** by and between **HIDALGO COUNTY, TEXAS** (the "COUNTY") and **Bio-Ops, LLC** (the "Contractor"). **WHEREAS**, COUNTY and CONTRACTOR entered into a Contract on November, 18 2014 (the "CONTRACT"), and which has been extended by agreement with an expiration date of December 13, 2017, in which the CONTRACTOR agreed to provide collection services of medical waste for the COUNTY, including but not limited to, the Hidalgo County Health & Human Services Department, the WIC Program, the Adult Detention Facility, Juvenile Probation Department and all Mobile Clinics, as well as other services as described in the CONTRACT; and

WHEREAS, the COUNTY due to certain circumstances now requires further clarification of the services to be provided by the CONTRACTOR and hereby requires the amendment of the Contract; and

WHEREAS, the COUNTY desires the CONTRACTOR to provide the services as described in the **Specifications/Requirements**, attached hereto as **Exhibit "A"**, to the Hidalgo County Forensic Center located at 3100-A South Business 281, Edinburg, Texas 78539; and

WHEREAS, the COUNTY and CONTRACTOR now desire to amend the CONTRACT as hereinafter provided.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, COUNTY and CONTRACTOR hereby agree to the following amendment to the CONTRACT

1. Exhibit "A" – Attachment "A", Waste Pick-up Schedule, shall be amended herein to include the Hidalgo County Forensic Center located at 3100-A South Business 281, Edinburg, Texas 78539,

2. Exhibit "A"-Specifications/Requirements & Exhibit "B"- Bid Page to now include any fees for additional services described herein, subject to the limitations of the Contract.

3. Except as modified herein, all terms and conditions of the CONTRACT, as amended, remain in full force and effect. COUNTY and CONTRACTOR ratify and confirm the terms and provisions of the CONTRACT as amended herein.
