Consent Agenda Item 10.G.2 (AI-58298) – Purchasing Department

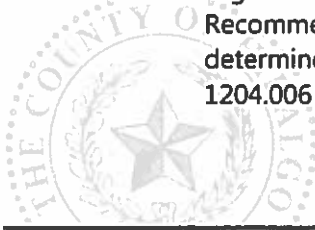
Point of Information: Requisition #313223 is to upgrade the equipment panel not for monitoring services.

Consent Agenda Item 10.N. (AI-58331) – Purchasing Department

Recommend No Action: The invoice is for two separate FEMA projects (programs 807 and 809). The invoice and/or schedule of values needs to be split between the two FEMA projects in order to process the payment. In addition, the period of performance for this FEMA project (PW-01362) was 03/08/16-11/29/16. A six-month extension was submitted; however, we have not received confirmation that the extension was approved.

Recommend No Action: The monthly payment amount on the Lease Test, which is used for the purpose of determining whether the lease is a capital or operating lease for reporting purposes, is incorrect.

We could not verify the FMV of the equipment for the purpose of determining whether the lease is a capital or operating lease for reporting purposes and for compliance with Local Government Code Sec. 271.005(c) and Government Code Sec. 1204.006 related to the maximum net effective interest rate.

Point of Information: Information on the current appointments (e.g., current member name, date term expires, etc.) was not provided. In addition, the by-laws, charter, etc. or sections thereof that speak to the composition and qualifications of the Board were not attached.

Recommend No Action: The Proclamation was not attached.

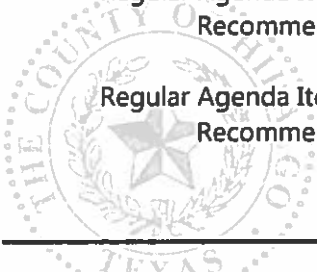

Regular Agenda Item 10.D. (AI-58380) – Human Resources

Recommend No Action: The Domestic Violence Court Grant only allows one position to be paid a supplement. An amendment to the grant contract is required for the requested action. In addition, pursuant to the attached Personnel Adjustment Request (PAR) forms and fiscal note the supplement for slot 0003 is \$2,320 instead of \$3,000 and the supplement for slot 0005 is \$9,250 instead of \$12,000.

Regular Agenda Item 22.B.2 (AI-58248) – Budget & Management

Recommend No Action: There are insufficient funds for this appropriation.

Regular Agenda Item 23.A.2.b (AI-58379) – Purchasing Department

Recommend No Action: The Agreements for Constable Pct. 1 and Constable Pct. 3 were not attached. In addition, legal counsel's review and approval of the agreements for the District Judges and Constables was not documented. Also, the Certificate of Interested Parties (FORM 1295) was not attached for the Constables. Therefore, we could not determine compliance with Section 2252.908 of the Government Code. Furthermore, FORM 1295 for the District Judges shows the business entity name as "RELX, Inc." instead of "Lexis Nexis."

Recommend No Action: The list of items to be declared surplus (Exhibit A) was not attached.

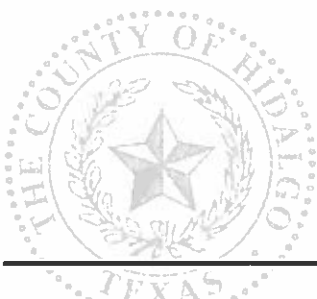
