The Health and Human Services Commission (HHSC) announces the expected availability of Fiscal Year (FY) 2018 funds to provide Prenatal Medical and Dental services. The funding for FY2018 for your agency is **\$144,029**. The FY2018 Title V Prenatal Renewal Application is attached.

Contract renewals are anticipated to begin on Sept. 1, 2017 and will be for a 12-month budget period ending Aug. 31, 2018; however, services may not begin until HHSC issues a written Notice to Proceed.

All contractors are expected to provide services in or benefiting the county or counties defined in your completed response, unless a different situation is specifically stated in the continuation packet (for example, as a result of a clinic closure or a previously approved program revision). Contract continuation is contingent upon the continued availability of funds and the satisfactory performance of the contractor during the current budget period.

HHSC reserves the right to alter, amend or withdraw this offer at any time prior to the execution of a contract if funds become unavailable through lack of appropriations, budget cuts, transfer of funds between programs or agencies, amendment of the appropriations act, Health and Human Services agency consolidations, or any other disruption of current appropriations. If a contract has been fully executed and these circumstances arise, the provisions of the Termination Article in the contract General Provisions shall apply.

Please submit the renewal application forms based on your award amount total (noted above) **by 5:00 pm, CDT, Tues., Feb. 28, 2017**. These documents should be sent to ContractMgmt@hhsc.state.tx.us.
