**MEMORANDUM OF UNDERSTANDING BETWEEN  
HIDALGO COUNTY CRIMINAL DISTRICT ATTORNEY AND THE TEXAS VICTIM  
SERVICES ASSOCIATION**

This Memorandum of Understanding is made on this \_\_\_\_\_ day of \_\_\_\_\_ 2017 by and Between the **HIDALGO COUNTY CRIMINAL DISTRICT ATTORNEY**, hereinafter referred to as “HCDA” or “COUNTY”, with administrative offices located at 100 E. Cano, Edinburg, TX 78539, and **the TEXAS VICTIM SERVICES ASSOCIATION hereinafter** referred to as “TVSA”, a non-profit organization with its principal office located at 6800 West Gate Blvd, Suite 132, Box 376, Austin, TX 78745-9997.

The safety and general welfare of the citizens of Hidalgo County is a common objective of both parties. Further, it is the objective of both parties to collaborate with partners in the community in an effort to educate the constituents in Hidalgo County about resources available for victims of crime.

Therefore, the aim of this Understanding is to establish an agreement for COUNTY to participate in the TVSA’s upcoming “Annual Conference & 20<sup>th</sup> Anniversary Celebration” with a common goal of educating the community about access to victim services and other resources available to citizens in HIDALGO COUNTY. Specifically, TVSA and COUNTY agree to work cooperatively toward the aforementioned goal as described more fully below.

**I. PROVISIONS OF SERVICES**

Through this Agreement the parties shall develop a cooperative program to provide services as follows:

The participation of TVSA in this initiative shall consist of the following:

1. TVSA is hosting the Annual Conference & 20<sup>th</sup> Anniversary Celebration on May 2-5, 2017, in the City of South Padre Island, Texas, which will provide training to criminal justice professionals in Hidalgo County on available resources for victim services.
2. TVSA will provide COUNTY an opportunity to participate in the aforementioned Conference so that COUNTY may provide educational information and resources to its constituents.

3. TVSA will allow COUNTY's participation in the Conference by including members of a team which will include but is not limited to the following: Hidalgo County District Attorney's Office- Victims Unit.

The participation of COUNTY/HCDA in this initiative shall consist of the following:

1. COUNTY/HCDA will provide personnel and resources to participate in the Conference for the purposes of providing educational information and access to victim services for constituents.
2. COUNTY/HCDA will assist in the coordination of program-related activities and events for purposes of promoting the general safety and welfare of its constituents.
3. COUNTY/HCDA will contribute (ONE THOUSAND FIVE HUNDRED DOLLARS AND NO 100/ths) \$1,500.00 for program activities and participation in the Annual Conference & 20<sup>th</sup> Anniversary Celebration scheduled to take place on May 2-5, 2017.

## **II. TERM OR AGREEMENT**

The term of this agreement is for one year; it will begin on **April 5, 2017**, and end on **April 5, 2018**.

## **III. COMPENSATION**

COUNTY/HCDA will receive no reimbursement from TVSA for any services provided under the agreement. COUNTY/HCDA will contribute \$1,500.00 to TVSA for its participation in the Conference and for services provided as described herein.

This Agreement may be amended, modified or terminated by agreement of the parties. Further, the agreement may be terminated by either party by giving thirty (30) days written notice via certified mail, return receipt requested to the other party hereto of the intention to terminate.

**VI. LAW GOVERNING VENUE**

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas, and, obligations and undertakings of each of the parties to this Agreement shall be performable in Hidalgo County, Texas.

**VII. LIABILITIES**

This Agreement is not intended to extend the liability of the Parties beyond that provided by law. Neither party waives, nor shall be deemed to have hereby waived, any immunity or defenses that would otherwise be available to it against claims arising from third parties.
