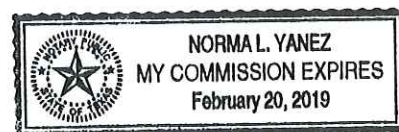

Minutes Excerpt

Item #1. Public Hearing to amend 2016 CDBG Workplan; delete park project and expand fire station project budget.

Councilwoman Alvarado motioned and Councilman Saucedo seconded to open the public hearing at 6:15 pm. The motion carried unanimously.

Mike Mesa, Grant Writer, stated staff was recommending the following budget amendment to the 2016 CDBG program budget:

Mr. Mesa stated the amendment would basically delete the public facilities line item and increase the fire station equipment line item to \$251,975. With no further comments, Councilwoman Alvarado motioned and Councilman Saucedo seconded to close the public hearing. The motion carried unanimously.

After public hearing and with no additional comments, Councilwoman Alvarado motioned and Councilman Garza seconded to amend the Year 29 (2016) CDBG Program Budget as presented and recommended by staff in the public hearing. The motion carried unanimously.
