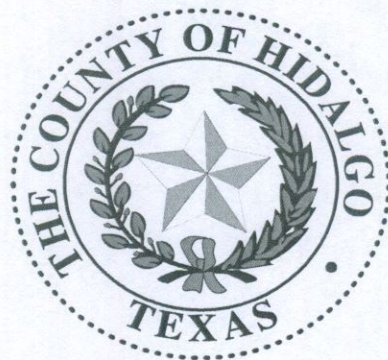

Dear Judge and Commissioners:

In accordance with Local Government Code Section 111.093, a requisition issued or a contract for work, labor, services, or materials and supplies is not binding until the county auditor certifies that the budget contains an ample provision for the obligation and that funds are or will be available to pay the obligation when due. Recommend that agreements/contracts be revised to include the County Auditor's signature as certification of available funds.

Point of Information: The correct invoice amount for Invoice 11326212 is \$51,977.68 not \$51,997.68 as stated on the agenda caption.

Recommend No Action: Pursuant to Local Government Code § 262.011 (d), the county purchasing agent shall contract for all repairs to property used, by the county or a subdivision, officer, or employee of the county. A person other than the county purchasing agent may not make the contract for repairs. In addition, LGC Sec. 262.011 (f), states, "The county auditor may not draw and the county treasurer may not honor an electronic transfer, check, or warrant for a purchase unless the purchase is made by the county purchasing agent or on competitive bid as provided by law." The invoice is for repairs obtained without a purchase order.


