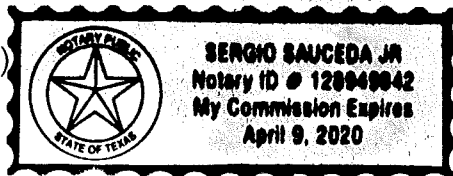
1. Membership in the association is for the betterment of county government and the benefit of all county officials;
