The last two accidents happened in the past 3 months. I would like some action to taken by the county to prevent more accidents such the ones that appear in these photos.

Listed below are dates of accidents and the cost we have had to pay to repair the damages.

October 28, 2014- Mcallen Pd crashed into our mailbox during a pursuit. \$175.00 (Mcallen PD reimbursed us for the damages)

February 1, 2015- Drunk driver was speeding and fled the scene. ( Silver Saturn car) \$2,115.00

November 27, 2016- Drunk driver was speeding and did not know pavement ended. An agreement was made for reimbursement but was never received. ( Black Cadillac) \$2,455.00

January 31, 2017- Young man speeding and lost control due to not knowing pavement ended. 16 year old passenger is currently in ICU for injuries that occurred in this crash. ( Red Chevy Truck) Cost of repair is estimated to be \$8,500.00

Please let me know if you need anymore information and please keep me updated because I am trying to ensure the safety of my family, children and our fellow county citizens. Thank you for your time. Please let us keep everyone safe and prevent lives being lost in the future.
