- Page 1-just the name which is OK (they added Consolidated in two areas)
- Page 2 Item # 6 – they added “if available”
- Page 2 Item # 9 – They took out the Name and Added “District” – I think it is OK
- Page 3 they just changed the name again and added Consolidated.
- Page 4 item # 24 – they changed where it used to say “ each party” they changed it to just “County”
- Page 6 we used to have an Item #25 – **Mutual Indemnification** and that was deleted from their sign interlocal.

Those are the changes I saw different can you have legal approve before I send it to Commissioners Court to sign I really would appreciated.
