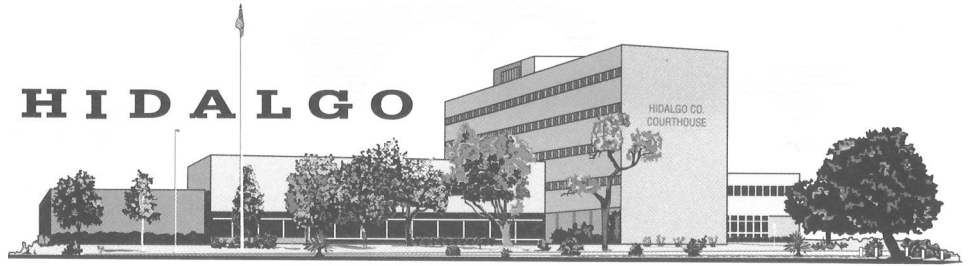

RE: Agenda Concerns

Dear Judge and Commissioners:

In accordance with Local Government Code Section 111.093, a requisition issued or a contract for work, labor, services, or materials and supplies is not binding until the county auditor certifies that the budget contains an ample provision for the obligation and that funds are or will be available to pay the obligation when due. Recommend that agreements/contracts be revised to include the County Auditor's signature as certification of available funds.

Consent Agenda Item 12.C. (AI-59561) – Purchasing Department

Recommend No Action: The Certificate of Interested Parties (FORM 1295) was not attached. Therefore, we could not determine compliance with Section 2252.908 of the Government Code.

Regular Agenda Item 9.B. (AI-59852) – Executive Office

Point of Information: The agenda caption indicates that the Classification and Compensation Plan will apply to ALL County Departments and Offices; however, those positions whose salaries are not set by the Commissioners Court (e.g., county auditor, assistant auditors and court reporters) should be exempt from the Plan. In addition, the Classification Position List includes some positions of the County Auditor's Office that should be removed.

Regular Agenda Item 9.E. (AI-59794) – Executive Office

Recommend No Action: Pursuant to Local Government Code § 262.011 (d), the county purchasing agent shall purchase all supplies, materials, and equipment required or used by the county or a subdivision, officer, or employee of the county. A person other than the county purchasing agent may not make the purchase of supplies, materials, or equipment. In addition, LGC Sec. 262.011 (f), states, "The county auditor may not draw and the county treasurer may not honor an electronic transfer, check, or warrant for a purchase unless the purchase is made by the county purchasing agent or on competitive bid as provided by law." The invoice is for software obtained without a purchase order.

Regular Agenda Item 12.F.2.C (AI-59582) – Health & Human Services Department

Recommend No Action: The budget appropriation from the General Fund was not attached.
