> Good afternoon Please accept this as our written request to amend our
> current contract with Network Sciences INC. We need to make software
> modifications to the indigent health care program to keep up with the
> changing structure of health care. The current specification are

> attached for your review. We need to add the following: Increase the
 > Federal Poverty Guideline (FPG) from 21% to 30% effective 9/1/17.
 (Pending
 > Commissioners Court approval)Add a second level of health care, County
 > Indigent Health Care Program (CIHCP) LEVEL 2 PILOT PROGRAM, for
 applicants
 > with FPG between 31% - 50%. (Pending Commissioners Court
 approval)The
 > CIHCP LEVEL 2 PILOT PROGRAM would follow Chapter 61 of the Health and
 > Safety Code with a few exceptions: 1. Federal Poverty Guideline
 is 31%
 > to 50 %2. Basic Services excluding hospital inpatient/outpatient
 with
 > the exception of lab and x-rays ordered at the hospital due to the
 > relationship with the hospital groups.3. Optional Services
 include
 > diabetic medical supplies and equipment only4. Maximum benefit
 per
 > fiscal year is \$3,000 per covered member5. Funding for claims is
 from
 > a different source than the CIHCP Program6. Create separate
 reports
 > and batches for CIHCP LEVEL 2 PILOT PROGRAM7. Create a different
 ID
 > card for CIHCP LEVEL 2 PILOT PROGRAM Option 1 is to continue to use
 the
 > existing Worksheet Form 101. Both programs would appear in the
 Program
 > dropdown at the top of Form 101. This option, with all other changes
 > mentioned above, we estimate to not exceed \$5,000 Option number 2 is
 to
 > use the new Automated Certification Form which does much more
 calculation
 > and provides prompts along the way for the required proof
 documentation.
 > The Automated Certification Form also provides referral outcomes for
 > Medicaid, CHIP and QHP which are then used in the determination rules
 for
 > your programs. For example, Clients who are potentially eligible for
 > Medicaid would be disqualified from CIHCP and Clients who are already
 > enrolled in SSI with Medicaid would be disqualified and their income
 and
 > resources would be automatically excluded. 1. The Automated
 > Certification Form will apply all of the rules for CIHCP and for CIHCP
 > LEVEL 2 PILOT PROGRAM based on the information entered and will
 > appropriately determine the Client eligible or not eligible for the
 > appropriate program. Estimate option Number 2 to not exceed \$15,000.

- > option may depend on the CIHCP State Office approving the use of our
- > Automated Certification Form in place of the Worksheet Form 101. DSHS has
- > approved our Certification Form as a replacement for another Worksheet that
- > was required for various Grant Programs. Please place on the earliest
- > agenda date. This request is necessary and needs to be approved quickly
- > so that we may have time to train the staff prior to our new fiscal year
