1. "Signed – C-17-179-06-13 Thomson Reuter-County Judge's Office": This is the signed contract that has the terms disclosed of 36 mo. with 3% annual increases from 6/15/17-6/30/20. This is the only place where you will be able to find the terms.

2. "Hidalgo County Judge Westlaw Modification Addendum": is our internal form that I will use that, once signed, will lapse the product called 'State Analytical' and replace it with a product called 'Analytical Plus.' This changing of products will not affect the terms of the original contract. This is simply a form that tells Thomson Reuters to lapse one product and replace with another. This changing of product will result in an increase of \$87.50 per month, making the new monthly bill \$250.00 per month, but the original terms will not be changed.
