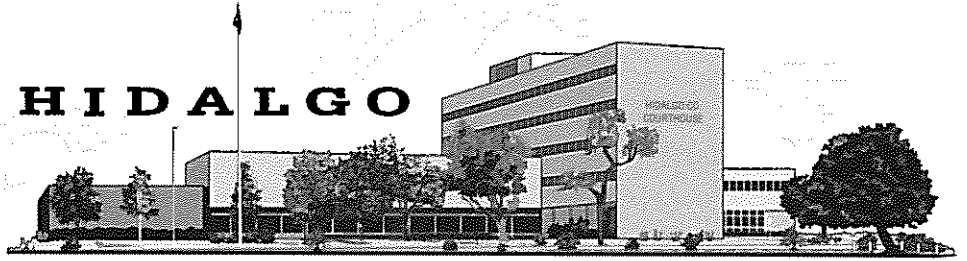

We have reviewed your written notice of the establishment of the Alamo Community Resource Center collection point and have approved a change fund in the amount of \$200.00.


According to Local Government Code Section 130.902, "The Commissioners Court of a county may set aside from the general fund of the county an amount approved by the County Auditor for use as a change fund by any county or district official who collects public funds. The fund may be used only to make change in connection with collections that are due and payable to the county, state, or another political subdivision of the state that are made by the official. On the recommendation of the county auditor, the Commissioners Court may increase or decrease the change fund at any time."

Please submit this letter to Commissioners Court requesting approval of the Alamo Community Resource Center collection point and of the change fund in the amount of \$200.00. Once Commissioners Court approval is obtained, please request a check from the Hidalgo County Auditor's-Accounts Payable Section to be made payable to "Eduardo Cantu, Commissioner, Precinct No. 2."

You will be responsible for this change fund. The change fund should be accounted for on a daily basis and safeguarded under lock and key. Please be reminded that this change fund is not to serve as petty cash or comingled with personal funds.
