As discussed, sections 3 and 5 of the online pharmacy service agreement has been modified to include the requested language regarding reference to the applicable fee schedule.

Additionally, provision No. 11 was modified to include the reference to the County's option to extend the contract for an additional year under the same rates, terms and conditions since this provision which is in the RFP was not in the agreement.

Additionally, the agreement did not include the reference to the County's option to extend the contract as provided in the RFP, so it was included in section 11.

Lastly, the date of approval by the Commissioner's Court on the last page reflected a date in the past, so it was removed and replaced with blanks.
