Partnership Coverage

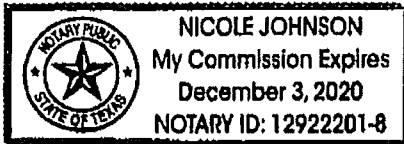
