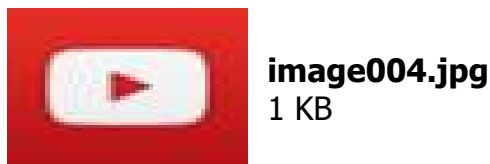
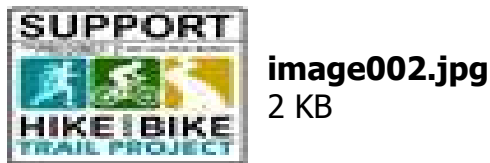
The improvements will be at the sole expense of the County. The City will not be contributing financially.
