It is Ordered that the vehicle being forfeited to the State of Texas be released instanter to the Hidalgo County Criminal District Attorney, as agent for the State of Texas, and the **HIDALGO COUNTY HIDTA TASK FORCE** in accordance with their local agreement and the Texas Department of Vehicle Title & Registration is ordered to issue valid certificate of title to the **HIDALGO COUNTY HIDTA TASK FORCE**.


