

AMENDMENT

This amendment ("Amendment") is made this by and between Tyler Technologies, Inc. ("Tyler") and Hidalgo County, Texas ("County") as of the last date signed by the Parties below ("Amendment Effective Date").

WHEREAS, Tyler and County are parties to a Participation Agreement dated July 24, 2007 ("Agreement"); and

WHEREAS, Tyler and County desire to amend the Agreement to add additional Licensed Software and Professional Services detailed in the attached Amendment Schedule 1.

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and the County agree as follows:

1. The Licensed Software and Professional Services detailed in the attached Amendment Schedule 1 are hereby added to the Agreement.
2. Tyler shall invoice County for the License Fees shown on Amendment Schedule 1 on the Amendment Effective Date.
3. Tyler shall invoice County for the Professional Services shown on Amendment Schedule 1 on a time and materials basis, and for all expenses related to providing such services as they are incurred. Payment shall be due 30 days following receipt of an invoice.
4. Upon the Amendment Effective Date, the Licensed Software added herein shall become subject to the then-current Maintenance and Support Services Agreement. Tyler shall invoice County a prorated share of the Maintenance and Support Fees detailed on Amendment Schedule 1 on the Amendment Effective Date for the period beginning on the Amendment Effective Date and continuing through the end of the County's current maintenance term. Thereafter, County shall pay Maintenance and Support Fees annually in advance and pursuant to the terms of the Maintenance and Support Services Agreement.
5. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement.
6. All other terms and conditions of the Agreement shall remain in full force and effect.

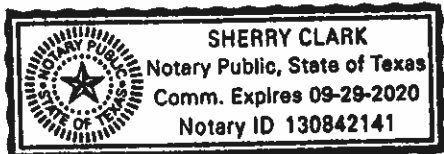
