The proposed amendment to the 2015 surplus funding will add the reconstruction of streets to Havana Subdivision under the street Improvements line item and also **CREATE** a new project line item for Parking Facilities. The parking facilities will be for Military Park project. The amendment for 2016 surplus funding will **DEDUCT** from the Street Improvements line item to **CREATE** the Parking Facilities line item for the construction of a parking lot at Military Park located within La Joya city limits.
