SDA Liaisons,

Our email of 10/9/2017 in which HHSC distributed the UHRIP applications for you to complete contained the following timeline:

- October 12 Applications for SDA sent out by HHSC
- October 16 Applications and IGT Commitment Amounts Due
- October 30 Call for IGT submitted to UHRIP participants
- November 3 Latest date to transfer funds into TexNet
- November 6 IGT Settlement Date

Since HHSC returned the applications to you for revision on 10/20/2017, HHSC has revised the target call for IGTs. The new target dates are:

- November 6 Call for IGT submitted to UHRIP participants
- November 10 Latest date to transfer funds into TexNet
- November 13 IGT Settlement Date

Governmental IGT entities will need to submit their IGT individually rather than having only the SDA Liaison transfer funds for the entire SDA. IGT entities are not registered in TEXNET will need to do so.
