Attached are the details from Texas Department of Licenses and Regulation concerning Mr. Garcia's Registered Sanitarian Licence.

The septic tanks rules (30 TAC 285) allowing a registered sanitarian to design a system are:

§285.60. Duties and Responsibilities of Site Evaluators.

(4) maintain a current professional engineer license, **professional sanitarian license**,

professional geoscientist license or certified professional soil scientist certificate, in addition to the site

evaluator license if the site evaluator license was granted on the basis of holding one of the licenses listed
