Good morning Ms. Ramirez,

Earlier this morning I spoke with Aissa Acevedo, Ricoh representative. She's spoken with their financial adviser at Wells Fargo and received approval to modify terms that reference the State of Pennsylvania to the State of Texas and to strike the language that we waive our right to trial by jury. All they ask is Judge to initial on both changes, which I don't foresee an issue with. Furthermore, an updated Master Lease Agreement will be sent my way. Once I receive it, I will forward it to you for review and request to approve as to form. She has also received approval to modify the same changes on each individual contract a department decides to enter into to match the MLA that supersedes any individual agreement.
