1. Mayor Moron called the public hearing to order at 6:15 p.m.
2. Present for the Public Hearing are as follow: Mayor Moron, Alderman Manuel Hinojosa, Alderman Mario Lopez and Alderman David Palomin

Absent: Mayor Pro-Tem Joe Contreras and Jorge Lopez

3. Mayor Moron informed the Board of the item that was on the Public Hearing Agenda. The item is as follow:
  - Public Hearing on Proposed Program Amendments UCP Years 27 (2014), 28 (2015) and 29 (2016)

Mayor Moron asked Mr. Amaro to read the Public Hearing Notice out loud. After Mr. Amaro finished reading the public hearing notice he informed the Board why the work plans needed to be amended. Mr. Amaro explained to the Board that he work plans needed to be amended to read 100,000 gallon elevated storage tank from 200,000 gallon elevated storage tank. Mr. Amaro informed the Board that with the amount of funds that had been allocated that we could not afford a 200,000 storage tank. After a brief discussion and there being no more discussion, Mayor Moron asked if there were any more questions and being that there wasn't Mayor Moron closed the public hearing.
